The fund aims to mimic the benchmark return and aim to deliver low tracking error through passively manage portfolio.

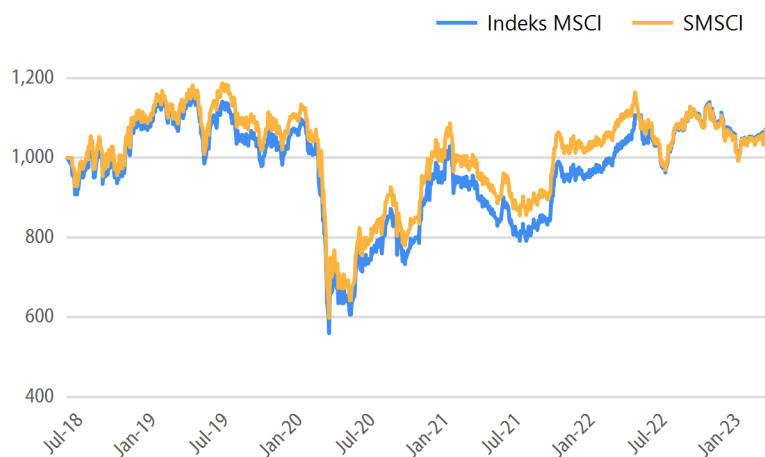
Investment Strategy
